MUNICIPAL ORDINANCE NO. 1
Series of 2021

“AN ORDINANCE IMPLEMENTING THE SEGREGATED GARBAGE COLLECTION POLICY OF THE LGU KNOWN AS “*SEGREGATED GARBAGE COLLECTION ORDINANCE*” AND ESTABLISHMENT OF GARBAGE PICK-UP POINTS IN STRATEGIC LOCATIONS IN ALL BARANGAYS IN THE MUNICIPALITY OF STA. TERESITA, CAGAYAN”

BE IT ENACTED by the Sangguniang Bayan of Sta. Teresita, Cagayan in session duly assembled, that:

Section 1. Title. This Ordinance shall be known as the **“Segregated Garbage Collection Ordinance of Sta. Teresita, Cagayan”**.

Section 2. Definition of Terms. As the purpose this ordinance, the following terms shall be defined to wit:

- a. Biodegradable Wastes – refer to compostable wastes, such as food scraps, fruit or vegetable peelings, wet paper, cardboard sheets, garden trimmings or twigs, cotton cloths, etc;
- b. Recyclable Wastes – those which can be utilized for other useful purposes (e.g. PET bottles, tyres, water gallons, tetra packs), etc;
- c. Residual Wastes - refer to garbage or wastes that can no longer be utilized for other useful purposes, such as single use plastics, disposable plastic cups, spoons and forks, styrofoam food boxes, candy or chip wrappers, sachets, plastic drinking straws, foil wrap, synthetic fibers, soiled diapers and sanitary napkins (except those used by ill persons), etc; type of wastes that go straight to the sanitary landfill;

- d. Segregated Garbage – wastes or materials for final disposal, which are separated at the point of origin, according to type, in order to reduce the volume of wastes for collection and disposal;
- e. Toxic/Hazardous Wastes (Hospitals) – those which are normally generated from the health facility, or those used by or on ill persons (e.g. soiled diapers and sanitary napkins, medicine vials, dextrose bottles, disposable face masks, PPEs, etc);
- f. Toxic/Hazardous Wastes (Households) – those which may cause harm or injury, such as broken glass jars or bottles, busted lamps, alkaline batteries, empty containers of paint, oil, thinner, gasoline, etc;

Section 3. Segregated Garbage Collection. As specified in Section 11 (c) of Municipal Ordinance No. 09, series of 2017, and as mandated under Chapter II, Section 10 (paragraph 2) of RA 9003, "segregation and collection of solid wastes shall be conducted at the barangay level specifically for biodegradable, compostable and reusable wastes, provided that the collection of non-recyclable wastes shall be the responsibility of the city or municipality". Furthermore, Section 32 states that "there shall be an established Materials Recovery Facility (MRF) in every barangay...", which shall "receive mixed wastes for final sorting, segregation, composting and recycling", such that the resulting residual wastes shall be collected by the Municipal Garbage Collection Team (MGCT), to be transferred to the Sanitary Landfill (SLF).

Section 4. Garbage Pick-up Points. There shall be established garbage pick-up points in strategic locations in all the 13 barangays of Sta. Teresita. These garbage pick-up points shall be located in the specific locations enumerated below, and their respective designated Focal Persons.

Section 5. Administrative Provisions.

- a. The "Tapat ko, Linis ko" strategy shall be strictly implemented. This includes trimming of tall grasses or weeds, and removing of silt or trash in drainage canals.

- b. The barangays shall establish a central MRF, where all generated wastes shall be sorted and segregated per garbage type. Compostable or biodegradable wastes should be deposited at the barangay communal compost pit.
- c. It shall be unlawful for any individual or entity to dump or throw mixed wastes or garbage anywhere other than the designated garbage pick-up point. It shall be the responsibility of the barangay to devise a collection strategy, which should be incorporated in their Barangay Ecological Solid Waste Management Plan.
- d. The designated Focal Person shall maintain a day-to-day record of the volume of wastes generated, collected, diverted, and transferred to the SLF thru the MGCT.
- e. Collection of wastes in all barangays shall be conducted daily, 10:00 AM (residual and special waste) and 3:00 PM (biodegradables and recyclables).

In order to accommodate all barangays, a regular schedule shall be strictly followed, to wit:

CLUSTERED BARANGAYS	DAY	TIME
Centro East, Centro West, Simpatuyo	Daily	AM/PM
Masi, Aridowen	Tuesday and Thursday	AM
Caniugan, Mission, Villa, Dungeg	Monday, Wednesday, and Friday	AM
Simbaluca, Buyun, Aluca, Luga	Monday, Wednesday, and Friday	PM

- f. It shall be unlawful for anybody to practice open burning of solid wastes, as one of the prohibited acts specified under Chapter VI, Section 48 (3) of RA 9003.

Section 6. Fines and Penalties. Any person who violates any provision of this Ordinance shall be penalized as follows:

- a. First Offense – fine of P300.00;
- b. Second Offense – fine of P500.00
- c. Third Offense – P700.00

Section 7. Repealing Clause. Ordinances which are inconsistent with the provisions of this ordinance are hereby repealed or revoked.

Section 8. Effectivity. This Ordinance shall take effect after fifteen (15) days of posting and broadcasting at the community radio station DWTS-FM.


