WHEREAS, Dupaya St. and Antiporda St. are among the roads in going to and from the public market thus they are the busiest roads in the poblacion;

WHEREAS, traffic obstruction thereat causes delay to commuters on their appointments especially students and workers;

WHEREAS, in order to ease the flow of traffic, there is a need to adopt some measures to regulate the passing of vehicles in the above-stated areas;

NOW THEREFORE, on motion of Honorable Mark Anthony P. Palor with the accord of all the members present;

RESOLVE, as it is hereby resolved by this August Body to enact the following ordinance to wit:

**MUNICIPAL ORDINANCE NO. 5  
SERIES OF 2021**

**"AN ORDINANCE DECLARING A PORTION OF DUPAYA ST. AND ANTIPORDA ST. OF BARANGAY CENTRO EAST, STA. TERESITA, CAGAYAN AS ONE-WAY TRAFFIC"**

BE IT ORDAINED by the Sangguniang Bayan of Sta. Teresita, Cagayan in session duly assembled that:

SECTION 1. There is hereby an ordinance declaring a portion of Dupaya and Antiporda Streets of Barangay Centro East, Sta. Teresita, Cagayan as one-way traffic;

SECTION 2. Order Of The Flow Of Traffic:

1. A portion of *Dupaya St.* particularly from the intersection of the national road in front of Talbo's Bakery to Tabiok Creek Bridge at Centro East is declared **ENTRANCE ONLY**.

2. Parking area along Dupaya St. shall be beside Public Market Building-I and front of Public Market Building-II.

3. A portion of *Antiporda St.* particularly from Tabiok Creek Bridge (between Centro East and Centro West) to intersection of the national road beside Madriaga's Building is declared **EXIT ONLY**.
4. Parking area along Antiporda St. shall be at the side of the old dilapidated public market building.
5. Strictly **NO DOUBLE PARKING** along Dupaya St. and Antiporda St.
6. Strictly **NO PARKING** along the road inside public market compound particularly between Public Market Buildings 2 and 3, and in front of Tourism Center.

SECTION 3. Signages shall be installed to provide information to road users and in order to warn and guide drivers passing through the said roads.

SECTION 4. Implementors of this ordinance shall be the PNP and Barangay Tanods of Centro East and Centro West.

SECTION 5. Penalty. Any violation on the provisions of Section 2 of this ordinance shall be fined with P200.00;

Fifty percent (50%) of the fines collected shall accrue to implementors of the above-mentioned ordinance which shall be released every quarter.

SECTION 6. This ordinance shall take effect 10 days after posting and broadcasting at the community radio station of the municipality.
