MUNICIPAL ORDINANCE NO. 6
Series of 2021

“AN ORDINANCE PRESCRIBING RENTAL FEES OF STALLS AT THE STA. TERESITA PUBLIC MARKET BUILDING-III”

BE IT ENACTED by the Sangguniang Bayan of Sta. Teresita, Cagayan in a session duly assembled that:

SECTION 1. There is hereby an ordinance prescribing rental fees of stalls at the Sta. Teresita Public Market Building-III.

- a. Stalls No. III-01, III-02, III-03, III-04, III-05, III-06, III-07, III-08, III-16, III-17, III-32 at P3,000 per month;
- b. Stalls No. III-09, III-10, III-11, III-12, III-13, III-14, III-15, III-18, III-19, III-20, III-21, III-22, III-23, III-24, III-25, III-26, III-27, III-28, III-29, III-30, III-31 at P2,500 per month

SECTION 2. Terms and conditions and other rules and regulations pertaining to the occupancy of the above stalls shall be stipulated in the Contract of Lease executed by the lessee and the lessor;

SECTION 3. Person With Disability (PWD) occupants shall be granted P500 discount of rental fees per month;

SECTION 4. This Ordinance shall take effect after 10 days of posting and broadcasting at the community radio station of the municipality.
