WHEREAS, this municipality is in the process of updating its Comprehensive Land Use Plan wherein the services of a Technical Consultant to help in the formulation of the said plan is crucial;

WHEREAS, to smoothly implement the project, there is a need to grant authority to the Municipal Mayor to enter into Contract of Services where terms and conditions to be entered into by both parties are clearly defined therein;
