RESOLUTION NO. 09-2021

A RESOLUTION REQUESTING THE MUNICIPAL AGRICULTURE OFFICE, STA. TERESITA POLICE STATION AND MUNICIPAL TREASURY OFFICE TO ESTABLISH CHECKPOINTS AT ARAGAO, ALUCAO AND MISSION IN THE MUNICIPALITY OF STA. TERESITA, CAGAYAN

WHEREAS, the present administration of Sta. Teresita through this August Body would like to protect the municipality from the entry of the African Swine Fever (ASF) a highly contagious viral disease affecting both domestic and wild pigs of all ages;

WHEREAS, the prevalent entry of non-resident buyers of swine/hog without necessary permit is likewise observed;

WHEREAS, the establishment of checkpoints will ensure the verification and security checks of all entries thus strengthening the protection of the municipality particularly against ASF infected hogs and to deter and apprehend illegal hog traders;

NOW THEREFORE, on motion of Honorable Jefferson M. Javier duly seconded by Honorable Jose I. Gonzaga;

RESOLVE, as it is hereby resolved by this August Body to request the Municipal Agriculture Office, Sta. Teresita Police Station and Municipal Treasury Office to establish checkpoints at Aragao, Alucao and Mission in the municipality of Sta. Teresita, Cagayan;

RESOLVED FURTHER, to furnish copies of this resolution to Municipal Agriculture Office, Sta. Teresita Police Station and Municipal Treasury Office for information and appropriate actions.


