"A RESOLUTION REGULATING THE PRICES OF BEEF AND CARABEEF IN THE MUNICIPALITY OF STA. TERESITA, CAGAYAN."

WHEREAS, presented for consideration is the letter of Sta. Teresita Beef & Carabeef vendors requesting this August Body to increase the prices of beef and carabeef considering the current prices of live cow and carabao, the shortage of supply of said meat and the increasing demand from consumers;

WHEREAS, the Committee on Market Enterprises conducted a survey from other municipalities on the existing prices of beef and carabeef and decided to adopt the prevailing prices, to wit:

- Lean meat : ₱ 240.00/kilo
- Papaitan : ₱ 240.00/kilo
- Buto-buto/bulalo : ₱ 170.00/kilo

NOW THEREFORE, on motion of *Honorable Jethro S. Tibuc* with the accord of the majority;

RESOLVE, as it is hereby resolved by this August Body to regulate the prices of beef and carabeef in the municipality of Sta. Teresita, Cagayan;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and reference.


