"A RESOLUTION AUTHORIZING THE HONORABLE RODRIGO P. DE GRACIA, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY TO TRANSACT AND NEGOTIATE BUSINESS WITH LICENSED BUSINESS ENTERPRISE FOR THE REHABILITATION OF MULTI-PURPOSE BUILDING (COMFORT ROOM) AT BARANGAY ARIDOWEN, STA. TERESITA, CAGAYAN"

WHEREAS, presented for deliberation and appropriate action is the Resolution No. 1-2021 of the Municipal Bids and Awards Committee declaring failure of bidding and recommending negotiated contract for the rehabilitation of multi-purpose building (comfort room) at Aridowen, Sta. Teresita, Cagayan;

WHEREAS, the Bids and Awards Committee had advertised the rehabilitation of multi-purpose building (comfort room) at Barangay Aridowen in the PhilGEPS on *December 16, 2020* and *January 21, 2021* respectively and posted the same at conspicuous places in the premises of LGU-Sta. Teresita for 14 calendar days but no qualified bidders have manifested interest as per BAC Resolution hereto attached;

WHEREAS, in the exigency of the service, this August Body decided to give full authority to the Municipal Mayor for the implementation of the project;

NOW THEREFORE, on motion of Honorable William A. Lorenzo duly with the accord of the majority;

RESOLVE, as it is hereby resolved by this August Body to authorize the Honorable Rodrigo P. De Gracia, Municipal Mayor, for and in behalf of the municipality to transact and negotiate business with licensed business enterprise for the rehabilitation of multi-purpose building (comfort room) at barangay Aridowen, Sta. Teresita, Cagayan;


