WHEREAS, the COVID-19 pandemic affected the world adversely particularly on health restoration and medicines and vitamins to counter its ill effect;

WHEREAS, the municipality of Sta. Teresita was among the LGU's that exhausted its fund for the purchase of medicines and vitamins in order to provide immediate response for the medical needs of its constituents;

WHEREAS, it is one of the primary duties of the government to provide timely services and reliefs to the people, hence this resolution;
