RESOLUTION NO. 25-2021

A RESOLUTION DECLARING THE LOT OWNED BY THE MUNICIPALITY OF STA. TERESITA, CAGAYAN WITH TCT NO. T-74632 LOCATED AT BARANGAY CENTRO EAST AS DESIGNATED IMPOUNDING AREA

WHEREAS, the Department of the Interior and Local Government issued Memorandum Circular No. 2020-031 to all Provincial Governors, City and Municipal Mayors, Punong Barangays, Presiding Officers of Local Sanggunians, DILG Regional Directors, BARMM Minister of Local Government and all other concerned for the mandatory establishment of impounding areas by Local Government Units;

WHEREAS, in compliance with said Memorandum Circular, this August Body declares the lot owned by the municipality of Sta. Teresita, Cagayan with TCT No. T-74632 located at Barangay Centro East as designated impounding area;

WHEREAS, above identified area shall be established as impounding area for the safekeeping of immobilized and towed vehicles on the streets that are illegally parked and stalled parked vehicles and other traffic violation offenses punishable with impoundment as prescribed in ordinance to include vehicle involved in accidents;

NOW THEREFORE, on motion of Honorable William A. Lorenzo with the accord of the majority;

RESOLVE, as it is hereby resolved by this August Body to declare the lot owned by the municipality of Sta. Teresita, Cagayan with TCT No. T-74632 located at Barangay Centro East as designated impounding area;


