A RESOLUTION EARNESTLY REQUESTING THE HONORABLE MARK A. VILLAR, SECRETARY, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF ₱40 MILLION FOR THE CONSTRUCTION OF MASI-LUGA RCDG BRIDGE IN THE MUNICIPALITY OF STA. TERESITA, CAGAYAN

WHEREAS, Masi River is the biggest source of irrigation system in the municipality which traverses the vast agricultural land of Barangay Aridowen, Masi, Luga and Simpatuyo;

WHEREAS, the absence of a bridge connecting barangay Masi and Luga greatly hampers the mobility of farmers and other commuters especially during rainy season wherein the said river is impassable;

WHEREAS, the construction of a bridge would permanently solve the problem of inaccessibility of good and services in the area;

NOW THEREFORE, on motion of Honorable William A. Lorenzo with the accord of the majority;

RESOLVE, as it is hereby resolved by this August Body to earnestly request the Honorable Mark A. Villar, Secretary, Department of Public Works and Highways to extend financial assistance in the amount of ₱40 Million for the construction of Masi-Luga RCDG bridge in the municipality of Sta. Teresita, Cagayan;


RESOLVED FURTHER, to furnish a copy of this resolution to the Honorable Mark A. Villar for his information and favorable action.
