A RESOLUTION EARNESTLY REQUESTING THE HONORABLE MARK A. VILLAR, SECRETARY, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF ₱50 MILLION FOR THE CONSTRUCTION OF RIVER CONTROL AT BARANGAY MISSION, MUNICIPALITY OF STA. TERESITA, CAGAYAN

WHEREAS, it has been the perennial problem of the barangay residents along the riverbank of Mission river that during inclement weather there has been an apparent continuous erosion of Mission river banks which pose hazard to the lives and properties of the people thereat;

WHEREAS, it has been noted that after two decades agricultural lands and even residential houses near the riverbanks have been eroded and washed out brought about by flash floods;

WHEREAS, if this problem is not immediately attended to, it will greatly affect the economic and social life of the local residents especially on the protection and safety of their lives and properties;

NOW THEREFORE, on motion of Honorable William A. Lorenzo with the accord of the majority;

RESOLVE, as it is hereby resolved by this August Body to earnestly request the Honorable Mark A. Villar, Secretary, Department of Public Works and Highways to extend financial assistance in the amount of ₱50 Million for the construction of river control at Barangay Mission, municipality of Sta. Teresita, Cagayan;
