A RESOLUTION EARNESTLY REQUESTING THE HONORABLE ALLAN U. TY, LPGMA PARTYLIST REPRESENTATIVE, CONGRESS OF THE PHILIPPINES TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF ₱20 MILLION FOR THE CONCRETING OF BUNGKAG FARM TO MARKET ROAD IN THE MUNICIPALITY OF STA. TERESITA, CAGAYAN.

WHEREAS, the municipality of Sta. Teresita is one of the major rice producing municipalities in the province of Cagayan and the main source of income of the local constituents is farming;

WHEREAS, Sitio Bungkag has vast agricultural land best suited for rice and crop productions, however, marginal farmers and the commuting public still suffer the inconveniences of travelling the said road due to its rugged condition;

WHEREAS, the said condition of Bungkag road has been identified by the municipal government as one of the topmost priorities but could not initially implement the same due to meager financial resources being a fourth class municipality and with limited income from local sources;

NOW THEREFORE, on motion of Honorable William A. Lorenzo with the unanimous accord of all the members present;

RESOLVE, as it is hereby resolved by this August Body to earnestly request the Honorable Allan U. Ty LPGMA Partylist Representative, Congress of the Philippines to extend financial assistance in the amount of ₱20 MILLION for the concreting of Bungkag Farm to Market Road in the municipality of Sta. Teresita, Cagayan;


