A RESOLUTION EARNESTLY REQUESTING THE HONORABLE CHRISTOPHER LAWRENCE "BONG" T. GO, SENATOR, SENATE OF THE PHILIPPINES TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF ₱20 MILLION FOR THE CONCRETING OF ALUCAO-BIGOC ROAD IN THE MUNICIPALITY OF STA. TERESITA, CAGAYAN

WHEREAS, the Local Government Unit of Sta. Teresita is a fourth class municipality with a very minimal IRA share which is not sufficient to finance its local infrastructure projects;

WHEREAS, despite of this financial limitations, the municipality is in its momentum to develop its natural resources wherein the development of agricultural land best suited for various crops productions is at priority level;

WHEREAS, in the process of development, the accessibility of farmers and the commuting public is very essential to cater the delivery of goods and services hence, the need to concrete its various farm to market road;

WHEREAS, the Alucao-Bigoc farm to market road is a major service road of farmers in going to and from their farmland and to transport their products to the market;

NOW THEREFORE, on motion of Honorable William A. Lorenzo with the unanimous accord of all the members present;

RESOLVE, as it is hereby resolved by this August Body to earnestly request the Honorable Christopher Lawrence "Bong" T. Go, Senator, Senate of the Philippines to extend financial assistance in the amount of ₱20 Million for the concreting of Alucao-Bigoc Road in the municipality of Sta. Teresita, Cagayan;


