**MUNICIPAL ORDINANCE NO. 10
SERIES OF 2021**

"AN ORDINANCE PRESCRIBING DISINFECTANT FEE TO ALL HOG BUYERS FROM OTHER MUNICIPALITIES ENTERING THE TERRITORIAL JURISDICTION OF STA. TERESITA, CAGAYAN"

BE IT ENACTED by the Sangguniang Bayan of Sta. Teresita, Cagayan in session duly assembled, that:

SECTION 1. Title. This Ordinance shall be known as the "Ordinance Prescribing Disinfectant Fee To All Hog Buyers From Other Municipalities Entering The Territorial Jurisdiction Of Sta. Teresita, Cagayan"

SECTION 2. Definition of Term:

Disinfection – the act of disinfecting something especially: the process of using a disinfectant to destroy, inactivate or significantly reduce the concentration of pathogenic agents (such as bacteria, viruses and fungi)

SECTION 3. Scope. All hog buyers coming from other municipalities entering the territorial jurisdiction of Sta. Teresita, Cagayan;

SECTION 4. Implementing Rules and Regulations:

- 4.a The three (3) border barangays (Alucao, Buyun and Mission) will be the checkpoint barangays and will serve as disinfection areas;
- 4.b The Municipal Agriculture Office will provide disinfectant solution with the help of Sanitary Inspector and the barangay officials will assign spray man to each checkpoint;

- 4.d The Municipal Treasurer's Office will be responsible for the collection of payment in the Checkpoint areas and 50% of the amount collected will be given to the barangays as their share.

SECTION 5. Penalty. Any violation on the provision of this ordinance shall be penalized with a fine of ₱300.00.


SECTION 6. Effectivity. This ordinance will take effect 10 days after approval, posting and broadcasting at the DWTS Community Radio Station of Sta. Teresita, Cagayan.
