MUNICIPAL ORDINANCE NO. 12
SERIES OF 2019

AN ORDINANCE AUTHORIZING THE LGU OF STA. TERESITA, CAGAYAN TO COLLECT REGISTRATION FEE OF ROTOVATOR AND DISC HARROW FOR HIRE WITHIN THE TERRITORIAL JURISDICTION OF STA. TERESITA, CAGAYAN.

(Sponsored by Honorable Jefferson M. Javier – Committee on Ways and Means)

BE IT ENACTED by the Sangguniang Bayan of Sta. Teresita, Cagayan in session duly assembled, that:

SECTION 1. There shall be collected as Annual Registration Fee to every person, partnership or corporation who shall operate rotovator and disc harrow within the territorial jurisdiction of the municipality, to wit:

	Resident Owner	Non-resident owner
ROTOVATOR	₱2,000.00 per unit yearly	₱3,000.00 per unit yearly
DISC HARROW	₱2,000.00 per unit yearly	₱3,000.00 per unit yearly
STICKER	₱100.00	₱100.00

SECTION 2. Definition of Terms:

- Rotovator** is a tractor-drawn implement which is mainly used for seed bed preparation within one or two passes and is suitable in removing and mixing residual of maize, wheat, sugar cane etc., thereby, helps to improve soil health and save fuel, cost, time and energy as well.
- Disc harrow** is a harrow whose cutting edges are a row of concave metal discs, which may be scalloped, set at an oblique angle. It is an agricultural implement that is used to till the soil where crops are to be planted. It is also used to chop up unwanted weeds or crop remainders.

SECTION 3. Schedule of Payments. All owners shall pay their annual fee not later than January 20 of the year that will cater their registration 'til December 31. Late registration will subject for additional fee of P1,000.00 per unit.

SECTION 4. Penalties. In case of any violation of the provision of this ordinance shall be penalized of the following manners:

1st offense – a fine of not less than P1,000.00

2nd offense – a fine of not less than P2,000.00

3rd offense – a fine of P2,500.00 or an imprisonment of not exceeding six (6) months or both fine and imprisonment at the discretion of the court.

SECTION 5. Implementing Agency. This Municipal Ordinance shall be implemented by the Business Permits and Licensing Office in collaboration with the Municipal Agriculture Office. It must be the duty of the Municipal Agriculture Office to submit the list of all the operators of rotovator and disc harrow for hire and copy furnish of the Sangguniang Bayan. Barangay officials shall also be deputized to implement this ordinance. The BPLO may call the assistance of the Barangay Tanods and/or Barangay Officials, PNP and any person in the implementation of this Ordinance.

SECTION 6. Incentives. A 20% incentive from the total fee collected is given as share to the Barangay that facilitates the on-time registration of rotovator/disc harrow and 30% incentive share in the facilitation of late registration of rotovator/disc harrow. The share due to the barangay shall be given on the fourth quarter of the year.


SECTION 7. Effectivity. This Ordinance shall take effect after ten (10) days of posting and broadcasting in the community radio of Sta. Teresita, Cagayan.
