#### MUNICIPAL ORDINANCE NO. 14 SERIES OF 2020

AN ORDINANCE REGULATING MASS GATHERINGS TO PREVENT THE SPREAD OF COVID-19 IN THE MUNICIPALITY OF STA. TERESITA, CAGAYAN

BE IT ENACTED by the Sangguniang Bayan of Sta. Teresita, Cagayan in session duly assembled, that:

SECTION 1. There is hereby an ordinance regulating mass gatherings to prevent the spread of COVID-19 in the municipality of Sta. Teresita, Cagayan.

SECTION 2. Coverage. This ordinance applies to the general public of Sta. Teresita, Cagayan whether resident or non-resident.

SECTION 3. In order to reduce transmission, contact and infection of the disease, the following protocols from the DILG Advisory dated June 11, 2020 are hereby adopted depending on the proclaimed level of community quarantine in this area, as follows:

- 3.1 For areas under Enhanced Community Quarantine (ECQ), Modified Enhanced Community Quarantine (MECQ) and General Community Quarantine (GCQ):
  - Only gatherings that are essential for the provision of essential government services or authorized humanitarian activities shall be allowed.
- 3.2 For areas under Modified General Community Quarantine (MGCQ)
  - Mass gatherings may be allowed as long as no more than 50% of the capacity of the venue or seating arrangement is occupied as well as the observance of stringent social distancing measures, and health and safety protocols. Religious activities shall be allowed under guidelines to be subsequently issued by the IATF.

SECTION 4. Penalty. Violation of this ordinance shall be penalized with the following:

1st offense – a fine of P1,500.00 per individual

 $2^{nd}$  offense – a fine of P2,000.00 per individual  $3^{rd}$  offense – a fine of P2,500.00 per individual

SECTION 5. Effectivity. This ordinance shall take effect immediately upon approval.
