**MUNICIPAL ORDINANCE NO. 15
SERIES OF 2020**

AN ORDINANCE BANNING THE CONDUCT OF COCKFIGHTING DURING THESE TIMES OF COVID-19 PANDEMIC IN THE MUNICIPALITY OF STA. TERESITA, CAGAYAN

BE IT ENACTED by the Sangguniang Bayan of Sta. Teresita, Cagayan in session duly assembled, that:

SECTION 1. Regulated Acts. No group of persons shall be allowed to conduct cockfighting during these times of community quarantine due to COVID-19 pandemic in the municipality of Sta. Teresita, Cagayan until such time that the same is allowed through an issuance of government agencies having jurisdiction on the matter.

SECTION 2. Coverage. The following individuals enumerated herein are those liable persons under this ordinance:

1. Participants – those persons who participate in the cockfighting including owners of fighting cocks;
2. Organizers – persons who organize and manage the conduct of cockfighting, including the judge or “sententiador”;
3. Lot owner – owner of the land where cockfighting is conducted for free or with a fee for the use of his lot;
4. Others who are present in the cockfighting site like bettors, spectators, canteen operators and all others who are present during the cockfighting activities.

SECTION 3. Penalty. Violation of SECTION 1 of this ordinance shall be penalized with the following:
1st offense – a fine of ₱1,500 and imprisonment of 2 days;
2nd offense – a fine of ₱2,000 and imprisonment of 7 days;
3rd offense – a fine of ₱2,500 and imprisonment of two (2) months


SECTION 4. Effectivity. This ordinance shall take effect immediately upon approval.


