WHEREAS, the municipality of Santa Teresita is one of the major suppliers of rice and corn in the Cagayan Valley Region due to its vast agricultural lands suited for crops production such that the main source of income of the local constituents is farming;

WHEREAS, despite of this positive trend of development, it is very unfortunate to note that this municipality is periodically visited by typhoons which left unprecedented number of damages both public and private properties more on infrastructure facilities;

WHEREAS, being a 4<sup>th</sup> class municipality this small town still lacks adequate agricultural infrastructures and facilities particularly farm to market roads which adversely affect the mobility of farm inputs and production of farmers;

WHEREAS, in response to the above needs and problems, the Municipal Development Council had identified and prioritized the following projects for funding allocation to wit:


