RESOLUTION NO. 81-2021

"A RESOLUTION TO SUSPEND TEMPORARILY THE PROVISION OF ANTI-RABIES VACCINE PARTICULARLY TO NON-RESIDENT OF SANTA TERESITA, CAGAYAN DUE TO THE EXISTING COVID-19 PANDEMIC."

WHEREAS, it is the commitment of the Municipal Health Office of Santa Teresita to deliver health services to the needy and one of its essential services is the provision of anti-rabies vaccine to residents and non-residents twice a week (every Mondays and Thursdays only);

WHEREAS, in view of the above, gatherings of patients composed of residents and non-residents is unavoidable and violation on safety protocols may be committed;

WHEREAS, in order to safeguard the health of the local inhabitants and to conform to the government restrictions in preventing the spread of COVID-19, there is a need to suspend temporarily the provision of the said vaccine especially to non-residents of Santa Teresita;

NOW THEREFORE, on motion of Honorable Jefferson M. Javier with the unanimous accord of all the members present;

RESOLVE, as it is hereby resolved by this August Body to suspend temporarily the provision of anti-rabies vaccine particularly to non-resident of Santa Teresita due to the existing of Covid-19 Pandemic;

RESOLVED FURTHER, to furnish copies of this resolution to all offices concerned for their information and reference.
