RESOLUTION NO. 82-2021

"A RESOLUTION APPROVING ORDINANCES OF BARANGAY SIMPATUYO, SANTA TERESITA, CAGAYAN"

WHEREAS, presented for deliberation and appropriate actions are the following Ordinances of Barangay Simpatuyo, to, wit:

1. Ordinance No. 2-2021 of Barangay Simpatuyo, prescribing fees to vendors selling essential commodities at the Talipapa of said barangay.
2. Ordinance No. 3-2021 of Barangay Simpatuyo regulating the burials of dead at Kayak Cemetery, prescribing fees and imposing penalties in violation thereof.
3. Ordinance No. 06-2021 of Barangay Simpatuyo regulating the drinking of intoxicating and fermented liquors in carinderias, sari-sari stores and video bars of minors in the said barangay

WHEREAS, the said ordinances were referred to Committee on Ordinances and Legal Matters and Peace and Order and after thorough review, the concerned committees found that the general purpose of said ordinances is for the welfare of the local inhabitants, thereby recommended for their approval as per Committee Report hereto attached, provided however that the effectivity of Barangay Ordinance No. 6-2021 shall be suspended during the existence of community quarantine;

NOW THEREFORE, on motion of Honorable Jose I. Gonzaga with the accord of the majority;

RESOLVE, as it is hereby resolved by this august body to approve ordinances of barangay Simpatuyo, Santa Teresita, Cagayan;


RESOLVED FURTHER, that a copy of this resolution be furnished to the Barangay Council of Simpatuyo for their information and appropriate action.
