"A RESOLUTION REQUIRING ALL COVID-19 POSITIVE PATIENT WHO UNDERGONE 14-DAY QUARANTINE PERIOD IN THE MUNICIPALITY TO UNDERGO ANTIGEN TEST TO BE CONDUCTED BY THE MUNICIPAL HEALTH OFFICE PRIOR TO HIS/HER RELEASE FROM QUARANTINE FACILITIES"

WHEREAS, COVID-19 positive patient must undergo antigen test after 2 weeks of quarantine however it is free of charge;

WHEREAS, if the patient antigen test result is positive, he/she will be required for another 7 days quarantine;

NOW THEREFORE, on motion of Honorable Jefferson M. Javier duly with the accord of the majority;

RESOLVE, as it is hereby resolved by this August Body to require all COVID-19 positive patient who undergone 14-day quarantine period in the municipality to undergo antigen test to be conducted by the Municipal Health Office prior to his/her release from quarantine facilities;


RESOLVED FURTHER, that copies of this resolution be furnished to all offices concerned for their information and reference.


