1. Construction of River Control at Mission River - P50,000,000.00
2. Concreting of Nanguilian Farm To Market Road - P20,000,000.00
3. Purchase and Installation of Solar Powered Streetlights - P20,000,000.00

WHEREAS, the Honorable Wendel C. Avisado is cognizant with the objectives of the government to spur development especially in the countryside through provision of infrastructure facilities;


RESOLVED FURTHER, that a copy of this resolution be forwarded to the Office of the Honorable Wendel C. Avisado for his kind consideration and favorable action.
