A RESOLUTION REGULATING THE PRICES OF MEAT (HOG) IN THE MUNICIPALITY OF SANTA TERESITA, CAGAYAN

WHEREAS, presented for consideration is the request of Hog Meat Vendors' Association for the increase of prices of meat (hog) in the municipality of Santa Teresita, Cagayan;

WHEREAS, after conducting dialogues, research and survey of the prevailing prices of hog meat in adjacent municipalities and after thorough discussion and evaluation of the measure, the body had come up with the decision and approved the following prices of meat (hog) to wit:

* Lean Meat	- P 270
* Liver	- P 270
* Bones	- P 220
* Intestines	- P 230
* Ribs	- P 230
* Live Weight	
- 80 kgs. and above	- P 180
- less than 80 kgs.	- P 160
- sow/boar	- P 140

WHEREAS, also included in the discussion and agreed upon by the Committee and the meat vendors is that selling of said meat be given priority to the residents of Santa Teresita;

NOW THEREFORE, with the accord of the majority;

RESOLVE, as it is hereby resolved by this August Body to regulate the prices of meat (hog) in the municipality of Santa Teresita, Cagayan;

RESOLVED FURTHER, to furnish copies of this resolution to all concerned for information and reference.


