A RESOLUTION AUTHORIZING THE HONORABLE RODRIGO P. DE GRACIA, MUNICIPAL MAYOR TOGETHER WITH 6 IDENTIFIED TARGET BENEFICIARIES TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES, REGIONAL OFFICE NO. 2 REPRESENTED BY OIC-REGIONAL DIRECTOR NELSON B. BIEN FOR THE "ESTABLISHMENT OF OYSTER TECHNO DEMO PROJECT USING RAFT CULTURE METHOD" IN THE MUNICIPALITY OF SANTA TERESITA, CAGAYAN

WHEREAS, one of the objectives of the Fisheries Program of the government is to increase fish farmers' productivity and profitability through the development and management of fishery resources thereby providing livelihood and additional source of income of fisherfolks;

WHEREAS, Oyster Culture in Raft Method is a proven technology to further increase oyster production and income for fish farmers with minimal cost of inputs;

WHEREAS, in view of this endeavor, the municipality of Sta. Teresita through the 6 identified fisherfolks namely Reymelinda M. Delgado, Jovillon G. Malazzab, Mary Ann P. Arcala, Ofelia G. Fuentes, Arman M. Pascua, Sr. and Rome C. Ramirez has been chosen as cooperators/beneficiaries for Oyster Techno-Demo Project using Raft Culture;

WHEREAS, to implement the project, the need to enter into a Memorandum of Agreement among the concerned parties whereby their respective responsibilities shall be incorporated therein;

NOW THEREFORE, on motion of Honorable Conrado P. Tabaco with the accord of the majority;

RESOLVE, as it is hereby resolved by this August Body to authorize the Honorable Rodrigo P. De Gracia, Municipal Mayor together with 6 identified target beneficiaries to enter into a Memorandum of Agreement with the Bureau of Fisheries and Aquatic Resources, Regional Office No. 2 represented by OIC-Regional Director Nelson B. Bien for the "Establishment Of Oyster Techno Demo Project Using Raft Culture Method" in the municipality of Santa Teresita, Cagayan
