WHEREAS, the body, through the Committee on Market Enterprises that conducted a survey from other municipalities on the existing prices of beef and carabeef, considers the prevalent increase of prices of feeds and other veterinary products in the local market and the increasing demand from consumers and the diminishing supply of said meat, hence, the body had come up with the decision and approved the following prices to wit:

Lean meat/Papaitan : ₱ 280
Bones/bulalo : ₱ 230

NOW THEREFORE, on motion of *Honorable Jethro S. Tibuc* duly seconded by *Honorable Jose I. Gonzaga*;

RESOLVE, as it is hereby resolved by this August Body to regulate the prices of beef and carabeef in the municipality of Sta. Teresita;


