A RESOLUTION EARNESTLY REQUESTING THE HONORABLE RONALD "BATO" M. DE LA ROSA, SENATOR, PHILIPPINE SENATE TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF ₱20 MILLION FOR THE CONCRETING OF CANIUGAN ROAD IN THE MUNICIPALITY OF STA. TERESITA, CAGAYAN

WHEREAS, the frequent occurrence of typhoons have washed-out and eroded roads particularly of barangay Caniugan which is now in a very rugged and bad condition;

WHEREAS, it is recommended that said road be concreted and once implemented it will surely benefit vehicles and motorists and pave their way for the faster transportation of goods and services;

WHEREAS, the municipality of Sta. Teresita with its limited funds could not be able to allocate enough funds for the concreting of said road;

WHEREAS, the office of the Honorable Ronald "Bato" de la Rosa is in the best position to allocate funds for the said project and be of big help in easing the hardship of commuting and travel time of people in Sta. Teresita in general;

NOW THEREFORE, on motion of *Honorable William A. Lorenzo* with the accord of the majority;

RESOLVE, as it is hereby resolved by this August Body to earnestly request the Honorable Ronald "Bato" M. de la Rosa, Senator, Philippine Senate to extend financial assistance in the amount of ₱20 Million for the concreting of Caniugan road in the municipality of Sta. Teresita, Cagayan;


