A RESOLUTION ADOPTING DEPARTMENT MEMORANDUM NO. 2016-0161 OF THE DEPARTMENT OF HEALTH REGARDING CALCIUM SUPPLEMENTATION FOR PREGNANT WOMEN.

WHEREAS, the Department of Health issued Department Memorandum No. 2016-0161 dated April 25, 2016 regarding calcium supplementation for pregnant women;

WHEREAS, it aims to reduce the risk of developing gestational hypertensive disorders and associated health problems thereby improving natural and newborn health and nutrition outcomes through provision of daily calcium supplementation to pregnant women;

WHEREAS, the general guidelines in calcium supplementation in pregnant women and additional instruction for administration are provided for in the memorandum;

RESOLVED FURTHER, to furnish copies of this resolution to all offices concerned for their information and reference.


