A RESOLUTION EARNESTLY REQUESTING THE HONORABLE NANCY S. BINAY, SENATOR, PHILIPPINE SENATE TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF PH&10 MILLION FOR THE CONCRETING OF ARIDOWEN-DUNGEG BARANGAY ROAD.

WHEREAS, the Aridowen-Dungeg road is one of the busiest roads in the municipality especially during planting and harvest seasons serving the barangays at the southeastern portion of the town;

WHEREAS, during rainy season, said road could hardly pass by small vehicles to the detriment of marginal farmers using the road and it is highly recommended that the said road be concreted to provide conveniences to the commuters and for further economic growth in their part because they can easily transport their agricultural products to the market;

WHEREAS, the local government unit of Sta. Teresita is a 4th class municipality and has no funds available to finance the project, hence this resolution;

NOW THEREFORE, on motion of Honorable Conrado P. Tabaco duly seconded by Honorable Gloria O. Baldiviso;

RESOLVE, as it is hereby resolved by this August Body to earnestly request the Honorable Nancy S. Binay, Senator, Philippine Senate to extend financial assistance in the amount of PH\(\text{P}\)10 Million for the concreting of Aridowen-Dungeg barangay road in the municipality of Sta. Teresita, Cagayan;
