WHEREAS, barangay Dungeg is located at the foot of the mountain whereby its wide valley is purely agricultural land best suited for any crop propagation;

RESOLVE, as it is hereby resolved by this August Body to earnestly request the Honorable Cynthia A. Teresita, Cagayan;

RESOLVED FURTHER to furnish a copy of this resolution to the Honorable Cynthia A. Villar for her information and favorable action;




