A RESOLUTION APPROVING MDC RESOLUTION NO. 5 SERIES OF 2020 RECOMMENDING ADOPTION OF ANNUAL INVESTMENT PROGRAM (AIP) FOR BUDGET YEAR 2021 AND APPROPRIATING THE AMOUNT OF PH₱122,367,717.00 BE ALLOCATED AND UTILIZED FOR PERSONAL SERVICES, MAINTENANCE AND OTHER OPERATING EXPENSES, CAPITAL OUTLAYS, 20% DEVELOPMENT FUND, GENDER AND DEVELOPMENT FUND ALLOCATION, AND MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT FUND AND ECONOMIC ENTERPRISES AS A BASIS IN THE ANNUAL BUDGET PREPARATION FOR CY 2021 OF THE MUNICIPALITY OF STA. TERESITA, CAGAYAN

Teresita, Cagayan;


