NOW THEREFORE, on motion of *Honorable Jose I. Gonzaga* with the accord of the majority;

RESOLVE, as it is hereby resolved by this August Body to adopt the Organizational Structure and Revised Staffing Pattern as of October 2020 of the Local Government Unit of Sta. Teresita, Cagayan;


RESOLVED FURTHER, to furnish copies of this resolution to all offices concerned for their information and appropriate action.
