WHEREAS, one of the priority projects of the present administration is to provide a sustainable power to electrify the streets and lanes of every barangay in the municipality of Sta. Teresita, Cagayan;

WHEREAS, the presence of streetlights is necessary and desirable to all concerned, as it could even serve as deterrence to the commission of crimes;

WHEREAS, the construction of the said project will provide better services to the constituents and to give them the opportunity to relax in outdoor activities even during nighttime;

RESOLVE, as it is hereby resolved by this August Body to earnestly request the Honorable Wendel C. Avisado Secretary, Department of Budget and Management to extend financial assistance in the amount of ₱30 Million for the purchase and installation of solar powered streetlights in the municipal wide of Sta. Teresita, Cagayan;


RESOLVED FURTHER, to furnish a copy of this resolution to the Honorable Wendel C. Avisado for his information and favorable action.
