A RESOLUTION EARNESTLY REQUESTING THE HONORABLE ARGEL JOSEPH T. CABATBAT, REPRESENTATIVE, MAGSASAKA PARTYLIST, CONGRESS OF THE PHILIPPINES TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF ₱20 MILLION FOR THE CONCRETING OF MASI TO LUGA ROAD, STA. TERESITA, CAGAYAN.

WHEREAS, the Local Government Unit of Sta. Teresita is a 4th class municipality with a very minimal IRA share which is not sufficient to finance its local infrastructure projects;

WHEREAS, despite of this financial limitations, the municipality is in its momentum to develop its natural resources wherein the development of agricultural land best suited for various crops production is at priority level;

WHEREAS, in the process of development, the accessibility of farmers and the commuting public is very essential to cater the deliveries of goods and services hence, the need to concrete the Masi-Luga road;

NOW THEREFORE, on motion of *Honorable William A. Lorenzo* with the accord of the majority;

RESOLVE, as it is hereby resolved by this August Body to earnestly request the Honorable Argel Joseph T. Cabatbat, Representative, Magsasaka Partylist, Congress of the Philippines to extend financial assistance in the amount of ₱20 million for the concreting of Masi to Luga road, Sta. Teresita, Cagayan;


