RESOLUTION NO. 41-2020

A RESOLUTION GRANTING SPECIAL AUTHORITY TO THE MUNICIPAL MAYOR TO ISSUE PERMIT TO HOLD A 3-DAY COCKFIGHTING IN CONNECTION WITH THE CELEBRATION OF 5TH NAMUNIT FESTIVAL (8TH ECOTOURISM FESTIVAL) IN THE MUNICIPALITY OF STA. TERESITA, CAGAYAN

WHEREAS, Article 100, (3) (v) of RA 7160 authorizes the Sangguniang Bayan to issue license for the establishment, operation and maintenance of cockpits and regulate cockfighting within the territorial jurisdiction of the municipality;

WHEREAS, the municipality of Sta. Teresita shall once again celebrate the 5th Namunit Festival (8th Ecotourism Festival) on March 10-14, 2020 at Luga National High School compound, Sitio Bangalao of Barangay Luga this municipality;

WHEREAS, the conduct of cockfighting "tupada" during fiestas and similar celebrations is a special event inherited by the Filipino people from the Spaniards and now part and parcel of the culture and tradition of every Filipino;

WHEREAS, aside from being an exciting game that highlights said festivities, it is also a way of sourcing out funds to augment the financial capabilities of the local government unit to carry out its plan of activities in celebrating the festival;

WHEREAS, this body recognizes the importance of the said activity to add colors and generate additional funds for the celebration hence, the need to allow its temporary operation subject to existing laws, rules and regulations of the municipal government;

NOW THEREFORE, on motion of *Honorable Jose I. Gonzaga* with the accord of the majority;

RESOLVE, as it is hereby resolved by this August Body to grant special authority to the Municipal Mayor to issue permit to hold a 3-day cockfighting in connection with the celebration of 5th Namunit Festival (8th Ecotourism Festival) in the municipality of Sta. Teresita, Cagayan;


