RESOLUTION NO. 52A-2020

A RESOLUTION DECLARING THE STATE OF CALAMITY IN THE MUNICIPALITY OF STA. TERESITA, CAGAYAN DUE TO COVID-19

WHEREAS, the overwhelming spread of COVID-19 in the different countries threatens the life of humanities in the whole world;

WHEREAS, Philippine Constitution Article II Section 15 states that it is the policy of the state to protect and promote the right to health of the people, thus, the Office of the President has issued Proclamation No. 922 s. 2020 declaring a State of Public Health Emergency throughout the Philippines and enjoining all government agencies and LGUs to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in timely manner to curtail and eliminate the threat of COVID-19;

WHEREAS, the present administration is one with the above-objective of the government to mitigate the effect of the COVID-19 in this municipality hence there is a need to declare a state of calamity;

WHEREAS, this declaration afforded this LGU to utilize appropriate funds, including the Quick Response Fund to contain the spread of the disease and to continue to provide basic services to the affected population;

NOW THEREFORE, on motion of *Honorable Jefferson M. Javier* duly seconded by *Honorable Jose I. Gonzaga*;

RESOLVE, as it is hereby resolved by this August Body to declare the state of calamity in the municipality of Sta. Teresita, Cagayan due to COVID-19;

RESOLVED FURTHER, to furnish copies of this resolution to all offices concerned for their information and appropriate actions.


