WHEREAS, the pandemic COVID-19 disease poses hazard to the health of humanity in the whole world and it is the duty of the government to protect the lives of the citizens thereby exerting efforts to fight and prevent the widespread of the disease in the country;

WHEREAS, according to study, the wearing of facemask by individuals when leaving their homes to work or to buy essential goods has the probability of having protection against the novel corona virus as it shields the face from the virus;

WHEREAS, in view of the above, Cabinet Secretary Karlo Nograles said all LGUs placed under Enhanced Community Quarantine shall adopt the policy of mandatory wearing of facemask by all residents whenever allowed to go out of their residences for further protection, hence this resolution;
