**RESOLUTION NO. 58-2020**

WHEREAS, the office of the President has issued Proclamation No. 929 (s. 2020) declaring the State of Calamity throughout the country and imposed an Enhanced Community Quarantine over the entire Luzon in light of the COVID-19 situation;

WHEREAS, the employees of the LGU of Sta. Teresita continue to report for work despite the Enhanced Community Quarantine due to the demand of public service by way of Flexible Work Arrangements;

WHEREAS, it is fit and proper to grant them financial assistance in order to recognize the efforts of the employees who rendered unselfish services notwithstanding the exposure to health risks and hazards;

WHEREAS, the LGU of Sta. Teresita has available funds and the amount of ₱ 465,000.00 derived from the General Fund is hereby appropriated for the above purpose;

NOW THEREFORE, on motion of Honorable Jose I. Gonzaga with the unanimous accord of all the members present;

RESOLVE, as it is hereby resolved by this August Body to grant financial assistance to all LGU personnel who continuously report for work during the period of implementation of the COVID-19 Enhanced Community Quarantine;


