RESOLUTION NO. 62-2020

"A RESOLUTION AUTHORIZING THE HONORABLE RODRIGO P. DE GRACIA, MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH DEL CASTILLO FUNERAL SERVICES REPRESENTED BY JAYLORD A. DEL CASTILLO FOR THE IMPLEMENTATION OF THE STANDARD PROCESS ON PROPERLY MANAGING HUMAN REMAINS OF PATIENT UNDER INVESTIGATION (PUI) AND CONFIRMED COVID-19 CASES IN THE MUNICIPALITY OF STA. TERESITA, CAGAYAN"

WHEREAS, the Department of the Interior and Local Government has issued Memorandum Circular No. 2020-063 dated March 27, 2020 which aims to provide interim guidelines on the management of human remains of those confirmed to have been infected with COVID-19 and those PUI who succumbed without confirmation of infection of said virus;

WHEREAS, in order to follow the above rule to contain the pandemic and to effectively implement the said activity, there shall be a Memorandum of Understanding to be entered into by the concerned parties wherein the responsibilities of both shall be stipulated therein, hence this resolution;

NOW THEREFORE, on motion of *Honorable Jose I. Gonzaga* with the accord of the majority;

RESOLVE, as it is hereby resolved by this August Body to authorize the Honorable Rodrigo P. de Gracia, Municipal Mayor to enter into a Memorandum of Understanding with Del Castillo Funeral Services represented by Jaylord A. Del Castillo for the implementation of the standard process on properly managing human remains of Patient Under Investigation and confirmed COVID-19 cases in the municipality of Sta. Teresita, Cagayan;

RESOLVED FURTHER, to furnish copies of this resolution to all offices concerned for their information and reference.


